Again this year, NAPS will award a prize of \$250 for the best first article in the field of patristics (which includes any discipline represented by the Society) that was published by a NAPS member in a scholarly journal. Articles should have appeared in print no earlier than January 2001. Any member of the Society may submit an article to the competition, regardless of whether that person is the author. Materials may be sent as off prints or photocopies. A short cover letter should state that the article is the author's first scholarly publication. Two search categories are found there: searches for quotable editions of the councils and searches for literature about them. Over 2000 books and articles on canon law as

decided by the early councils are available (e.g., issues of clergy, liturgy, penance, etc.), with a special category about the *modus procedendi* of the synods. The bibliography can be consulted either in Latin or German, with an English version soon to follow.
